I agree to all of the following Terms and Conditions. I understand that the Valor Youth Performance is a program offered by Valor Christian Schools ("School").

a. I understand and agree that assessments will be made to cover damage to School property, including but not limited to, all School physical property, furniture, fixtures, equipment, systems, technology, vandalism, and the like. We agree to promptly pay any such assessment.

b. My execution of this online registration gives permission for the Student named within the registration to take part in Valor Youth Performance activities. I am aware of the risks of accident, serious injury, and even death from participation in these activities and trips away from the School premises, and that in contemplation of such risks, I, and the Student, release the School, its officers, trustees, employees, and agents from any and all liability of any injury incurred by the Student at the School or during a School activity from any cause, including but not limited to the active or passive negligence of the School, but excluding gross negligence or intentional misconduct.

c. I hereby permit the School to use, in whole or in part, photographs, videos, written extractions, and voice recordings of my Student for the purpose of illustrations, publications, websites and marketing of the School or any of its programs. I further hereby permit the School to notify local or national news agencies of my Student's academic, athletic, and other special achievements.

It is recognized that the School reserves the right to dismiss the Student if and when, in the opinion of the School, his/her presence in the School is judged not to be in the best interest of the Student or is deemed to be detrimental to the welfare of the School or other students. I agree that the School will have the right to dismiss or require the withdrawal of any student whenever, in the exercise of its professional judgment, such dismissal may be appropriate, including without limitation, as a result of conduct contrary to School rules, regulations, or behavior expectations.

I hereby give permission for the Student named in the Registration to take part in all School activities, including sports, and trips away from the school premises, and I absolve the school from liability for any injury in a school activity. In the event of illness or accident to the student, I authorize any representative of the School to consent to any x-ray examination, anesthetic, medical or surgical diagnosis of the student, to transportation of the student to any hospital, and to treatment and hospital care. I shall indemnify and hold harmless the school and any representative of it from and against any and all liability, which may occur as a result of the exercise of the foregoing consent.
